THIS IS A RELEASE OF LIABILITY AND A WAIVER OF RIGHTS:**

**PARENT/GUARDIAN'S ASSUMPTION OF RISK AND WAIVER OF LIABILITY  
RELATING TO CORONAVIRUS/COVID-19**

The undersigned Parent/Guardian ("Parent" or "I") acknowledges and agrees as follows:

The novel coronavirus/COVID-19 ("COVID-19") continues to be a worldwide pandemic. Camp Juliette Low (the "Camp") is a summer camp owned by Camp Juliette Low, Inc. ("CJL"), a Georgia nonprofit corporation. Parent wishes for the Child/Camper named below ("Camper") to attend Camp and participate in Camp-related activities during 2023 and hereby enters into and signs this Assumption of Risk and Waiver of Liability ("Agreement") as a condition of and in consideration of CJL's allowing the Camper to attend Camp.

CJL has protocols to reduce the likelihood of spreading COVID-19 at the Camp; however, CJL cannot guarantee that Parent, Camper, or others will not become infected with COVID-19. Further, being at Camp and/or participating in Camp-related activities could increase Parent's or the Camper's risk of contracting COVID-19.

I understand that at all times, Camper and I are required to comply with all COVID-19 protocols of CJL, and for myself and Camper, I agree to comply.

I acknowledge the contagious and dangerous nature of COVID-19. I understand that exposure to or infection by COVID-19 may result in personal injury, illness, permanent disability, or death. I understand that CJL and the Camp cannot guarantee that I, the Camper, and others will not become infected with COVID-19, for reasons including the inherent danger of exposure and infection. In addition, part of the essential nature of Camp includes groups and gatherings of campers, CIT's, Counselors, and others in various settings, dining, tenting arrangements, and traditional Camp activities. For myself and for the Camper, I assume the risk that I, the Camper, other family or household members, or others traveling with or part of my group may be exposed to or infected by COVID-19 by being present at Camp or Camp-related activities. I sign this Agreement of my own free will.

I understand that the risk of becoming exposed to or infected by COVID-19 at Camp or Camp-related activities may result from actions, omissions, or negligence of myself, the Camper, or others, including, but not limited to, Camp or CJL employees, contractors, volunteers, other campers, and their families. I voluntarily agree to assume all the foregoing risks and accept sole responsibility for any illnesses or injuries to the Camper, me, other family or household members, or others traveling with or part of my group (including, but not limited to, personal injury, disability, or death), damages, losses, claims, liability, costs and expenses of any kind (collectively, "Claims"), that I, the Camper, other family or household members, or others traveling with or part of my group may experience or incur in connection with the Camper's attendance at Camp or any Camp-related activity.

On my behalf, and on behalf of the Camper, I hereby release, discharge, hold harmless, and covenant not to sue the Camp, CJL, and all its and their employees,

contractors, volunteers, trustees, officers, agents, and representatives, from or on account of any and all Claims, including all liabilities, actions, causes of action, damages, costs, or expenses of any kind arising out of or relating to such Claims. In the case of a Claim relating to a COVID-19 infection, this release, discharge, hold harmless, and covenant not to sue shall be binding whether an infection occurs before, during, or after participation in CJL's summer camp program.

I understand and agree that this release, discharge, hold harmless, and covenant not to sue apply to any and all Claims, including without limitation Claims based on the actions, omissions, or negligence of CJL, the Camp, or any of its or their employees, contractors, volunteers, trustees, officers, agents, and representatives.

I certify and represent to CJL that I am over 18 years of age, that I am legally competent to sign this Agreement, and that I have legal authority and capacity to act as the parent and/or legal guardian of the named Camper. I understand and agree that this Agreement is legally binding whether signed in person or by electronic signature, and whether delivered to CJL in an original document or any copy or facsimile thereof, including in electronic form by uploading, email, or any other manner.
