

Camp Juliette Low, Inc.

Application for CJL Daisy Sponsorship

The CJL Daisy Sponsorship will be offered as a pilot program for Summer 2027. This program is intended for girls who would not be able to attend CJL without full financial aid.

Sponsorships will cover all camp fees for one mini-camp, 1-week, or 2-week session, including registration, tuition, Trading Post deposit of \$50 per week, and a camp uniform T-shirt. Sponsorships will not cover additional costs that may be related to camp such as travel, luggage, or clothing.

Eligibility Criteria

- Girls between the ages of 8 and 17 with financial need are eligible to apply. To assess financial need, CJL will consider income eligibility guidelines for the USDA program for reduced price lunch. The USDA table showing eligibility is linked at the bottom of the following web page:

- Children and grandchildren of current Trustees, year-round employees, or executive employees are not eligible to receive this sponsorship. Children and grandchildren of seasonal employees are eligible if they meet other criteria.
- A separate CJL Summer Camp Application (available online at CJL's website, www.cjl.org) must be completed and submitted in addition to this application. A \$150 registration deposit is required with the camp application but will be refunded and covered by the sponsorship if selected. If the applicant is not selected, and will not attend camp, the fee is fully refundable.

Applications received by the deadline of November 1, 2026, will be reviewed and decisions reached in early December 2026. After this time, applications may continue to be accepted if sponsorships remain available.
